I/We the undersigned do hereby acknowledge receipt of our "Transaction Authorization Code" (TAC), "Wire Transfer Authorization Code" (TACW) or both. The TAC code **must** be used by me/us in order to transact any and all PFFCU business performed over the telephone, by mail, or in person, including funds into or out of my/our account(s). The TAC is not necessary if a PIN or password must be entered to access a service. I/We understand that if I/we select both of these options (TAC and TACW) above, it will be required for **all** account transactions (including wire transfers), and that if I/we select the "Wire Transaction Authorization Code" (TACW) only, it will only be required to authorize *wire* transfers.

I/We have chosen my/our TAC, which is shown above. I/We understand that this Transaction Authorization Code, along with any other requested information is for the sole purpose of identification and that failure to provide either or both, on request, will **prohibit** me/us from completing transactions or accessing information on my/our account with PFFCU. PFFCU reserves the right to request any other information necessary, in addition to the TAC and/or TACW, to verify a member's identity, to PFFCU's satisfaction, before completing any transaction.

I/We further understand that this Transaction Authorization Code may not be deleted or changed, except with the written consent of all joint owners on the account. If there is a change in the ownership of the account(s), a new TAC/TACW must be chosen for the remaining owners on the account. **In no event can or will a TAC and/or a TACW be used to limit the use or access of the account(s) by any other owner(s) of the account(s). Neither a TAC nor a TACW will be placed on an account or changed if this form is not completed properly.**

I/We agree that if this Transaction Authorization Code is lost, stolen, forgotten or otherwise, misplaced, I/we will apply to PFFCU for another code, and that each owner must sign and acknowledge receipt thereof. I/We also agree not to disclose the TAC/TACW to any person who is not an owner of this account. Any person providing the TAC/TACW, via telephone, mail, internet transaction, or in person along with any other information requested, will be deemed authorized to complete said transaction.

I/We understand and agree that the TAC and/or TACW is being placed on the account pursuant to my/our request and that PFFCU is not and will not be liable for any damages, whatsoever, including, but not limited to actual, consequential or punitive, for failure to complete any transaction because of my/our failure to provide my/our TAC and/or TACW, or other requested identification, or completing any transaction where the proper TAC/TACW was provided. In addition, I/we agree that PFFCU shall not be liable for not placing or changing a TAC and/or TACW on my/our account(s) if this form is not completed properly.

I/We hereby acknowledge receipt of PFFCU's Wire Funds Transfer Agreement, if I/we have chosen a TACW.
